

PERSONAL DATA PROTECTION REQUEST APPLICATION FORM

In the Law No. 6698 on the Protection of Personal Data (KVKK) the personal data owner (Applicant), who is defined as the person concerned, is given the opportunity to apply to the data controller regarding his/ her rights regulated in Article 11 of the KVKK.

Pursuant to the first paragraph of Article 13 of the KVKK; personal data owners are required to notify our Company, which is the data controller, with a written application regarding their requests regarding their rights or to deliver them to us by other methods determined by the Personal Data Protection Board.

Within this framework, applications to be made to our Company can be made in writing and by printing out this form;

- By the Applicant's personal application,
- By notary application,
- It can be signed by the Applicant with the "secure electronic signature" defined in the Electronic Signature Law No. 5070 and sent to our Company's registered electronic mail address (KEP).

Your applications submitted to us will be answered within thirty (30) days from the date of receipt of your request, depending on the nature of the request, in accordance with paragraph 2 of Article 13 of the KVKK. Our response will be delivered to you in writing or electronically in accordance with the provision of Article 13 of the KVKK.
